

SCHOOL GROUP PROGRAMS

Experiential Learning for School Groups, Grades 4-12

At the Crow Canyon Archaeological Center, we believe that the goal of education is to give students the intellectual tools they need to explore the world and think critically. We also believe that the optimal educational environment encourages students to actively participate in the learning process through hands-on activities and group discussion.

Crow Canyon's one-day field trips and overnight programs for school groups are designed for students in grades 4 through 12. Program modules vary depending on grade level, program length, and group size, but core activities teach students about archaeology, ancestral Pueblo Indian (Anasazi) history, the scientific process, and the complex interactions between people and their environments.

The Crow Canyon curriculum . . .

- is based on the belief that everyone's history matters
- articulates with National Education Standards in social science, history, science, geography, and math
- allows students to "experience the past" through hands-on activities at our pithouse and pueblo learning centers, which replicate Pueblo settlements during the seventh and twelfth centuries A.D.
- was developed in consultation with Pueblo Indians and other indigenous peoples to ensure that what we teach is accurate, respectful, and mindful of the connections between past and present



DESCRIPTION OF ACTIVITIES

Windows (or Inquiries) Into the Past





At the Pithouse Learning Center, students explore a replica of a seventh-century Basketmaker pithouse and engage in a variety of hands-on activities, including firestarting (with a bow drill), making fiber cordage, and "hunting" with spears and atlatls.

Pueblo Lifestyles

At the Pueblo Learning Center, students investigate a replica of a masonry pueblo, including rooms and a two-story tower. They discuss natural resources and farming practices, learn Pueblo games, and weave on an upright loom, to get a feel for Pueblo life in the twelfth century.

Simulated Excavation

Students get "hands-on" with the practical skills of field archaeology as they excavate and map site replicas representing different Pueblo time periods. Using the scientific method, students develop their own research questions and draw conclusions on the basis of their observations.

Field Excavation

Under the careful supervision of staff archaeologists and educators, students excavate at Crow Canyon's current site, contributing to the Center's ongoing research into ancestral Pueblo culture. (Note: In accordance with Crow Canyon policy, we do not seek human remains as objects of study.)

Site Tour

Emphasizing proper site etiquette, the educator leads students on a tour of a current or recent Crow Canyon excavation site. Students learn about ongoing fieldwork and the results of previous excavations at other sites in the area. (Required for students who will excavate in the field.)

Lab

Students wash, analyze, and catalog real artifacts from recent excavations. They also visit the curation room to see and discuss artifacts recovered from earlier excavations.

Pottery

Students discuss the importance of pottery to archaeologists as well as to the ancestral Pueblo people, and they use ancient techniques to make their own pottery vessels.



Anasazi Heritage Center Tour

Interactive exhibits on artifacts, analyses, and modern Pueblo perspectives enhance students' understanding of local archaeology. A short hike behind the museum to Escalante Pueblo affords a panoramic view of the landscape that was home to the ancestral Pueblo people.



Mesa Verde National Park Tour

Students typically visit this World Heritage site at the culmination of their program. They tour several excavated sites (including the famous cliff dwellings), visit the museum, and review the concepts they learned throughout the week.



Activities can be modified to accommodate the cultural concerns of American Indian students.



When and Where to Meet

Meet at the Piedra River Store at 9 AM:

Approximately 30 minutes from Durango, 20 minutes from Pagosa Springs

<u>Colorado Highway 160 at mile marker 121 in between Durango and Pagosa Springs</u>

Parking is free and there are outhouses at the river access point. Changing is done behind a tree, in the van, or in the outhouse

General Itinerary

9:00 AM Meet us at the Piedra River Store!

9:15 AM Depart in bus/van for the river

10:15 AM Arrive at river access point, change clothes, get ready for trip 10:45 AM Safety talk and rafting orientation

11:00 AM GO RAFTING!

4:00 PM Return to meeting place in bus/van

*everything except for the Meeting time is a rough approximation!

What is provided

- Top notch rafts, paddles, and other required gear
- Personal rafting gear: helmets, wetsuits, river shoes, PFD (life jacket), etc
- Transportation to and from meeting location
- Deli-style riverside lunch prepared by your guides
- Best river guides on the planet Earth!

What to Bring & Wear on the River

- Sunscreen
- Water bottle
- Dress to get wet!
- Clothing made from synthetic materials
- Swimsuits are ideal
- Synthetic shirt, fleece, or long underwear to compliment the wetsuit
- Wool or synthetic socks to wear with included neoprene river shoes
- Any emergency medications you might need: e.g. Epi-Pen, inhaler, etc
- Wear normal, warm street clothes and bring along the above items. At the river access
 point you will change into the clothes and gear to be worn while rafting. Your normal
 clothes will be stored in the bus/van during the trip and you will change into them
 once we get off the river.

What NOT to Bring & Wear

- Anything you do not want to get wet or lose on the river Expensive jewelry, phones, and electronics
- Towels
- Cotton clothing
- Valuables and other items can be locked in your car. We will hold onto your keys during the trip
